# 1. INVITATION

The International Fistball Association (IFA) in cooperation with CSIT and the local organizing team have the honor to invite all IFA members around the world to participate in the

which will take place in Cervia, Emilia Romagna, Italy, from

5-10 September 2023.

# 2. ORGANIZERS

The Organizer of the IFA CSIT 2023 Fistball Amateur World Championships Italy is the International Fistball Association (IFA) in cooperation with CSIT and the local organizing team EMILIOC.

# 3. PARTICIPATION, TEAMS AND QUOTA

The IFA 2023 Fistball Amateur World Championships Italy are open to all Federations affiliated to IFA as members.

Male, female and gender mixed teams are allowed. Each team may exist of a minimum of 6 players. It is possible to register more than one team. The tournament is played according to the Fistball - Rules of the Game.

These Games are not multisport games for top athletes, but for all amateurs (16 years and older) from different countries and cultures all over the world.

**Professional elite-athletes** (national team players from countries finishing in the Top 7 (Men) / Top 5 (Women) at the last World Championship or a team playing in the first national league) **have no right to participate! They are allowed to participate in the 2x2 Fistball competitions.** 

## 4. CATEGORIES AND AGE GROUPS

The IFA CSIT 2023 Fistball Amateur World Championship will be carried out in the following categories:

- Men's competition
- Women's competition

Tournaments are delivered in the following age groups:

Men 16+	Minimum age 16 years	2023: Year 2007 and older
Women 16+	Minimum age 16 years	2023: Year 2007 and older

**IFA CSIT 2023 Fistball Masters World Championships** 

Men 35+	Minimum age 35 years	2023: Year 1988 and older
Men 45+	Minimum age 45 years	2023: Year 1978 and older
Men 55+	Minimum age 55 years	2023: Year 1968 and older
Men 60+	Minimum age 60 years	2023: Year 1963 and older
Men 65+	Minimum age 65 years	2023: Year 1958 and older

**IFA CSIT 2023 Fistball Masters World Championships** 

Women 30+	Minimum age 30 years	2023: Year 1993 and older
Women 40+	Minimum age 40 years	2023: Year 1983 and older

A category is only carried out if at least 3 teams register. If in a Women's category are less than 3 teams registered, the teams will be integrated in the men's category.

Women playing in male teams is also allowed in all categories.

Furthermore IFA carries out the IFA CSIT 2023 2x2 Fistball Amateur World Cup in the following categories:

- Men
- Women
- Mixed

The categories are formed according to the number of registrations. Per category a minimum of 3 teams is necessary. If in the Mixed or Women's category are less than 3 teams registered each, the teams will be integrated in the men's category.

### 5. DIVERGENCES OF THE RULES OF THE GAME

The following divergences of the rules of the game are valid:

# 6. REFEREES / ASSISTANTS

Referees, linesmen and scorers are nominated by the participating teams according to the schedule.

## 7. TEAM REGISTRATION AND PAYMENT

2-step registration:

1st step: pre-registration on <a href="http://tiny.cc/CSITWSG-reg">http://tiny.cc/CSITWSG-reg</a> by registering your club latest by 15 May 2023, 24:00 CET.

Payment of 50 % of the total sum pre-payment: until 15 May 2023.

In this pre-registration the following details are needed:

- Club name
- Hotel categories
- Exact date of arrival and departure
- Contact details of the responsible person in your club

You don't need to register each team member in the first step, only the team itself.

**2<sup>nd</sup> step:** final registration latest by **20 June 2023**:

After your pre-registration you get an excel file to fill out the information on your respective team.

Payment of the remaining sum: 20 June 2023.

This final registration including the following details:

- Names of all team members
- E-mail addresses
- Gender

## 11. TRANSPORTATION

Special branded (WSG-Logo) shuttle buses are available from and to the below mentioned airport and railway station.

Public transportation in the cities of Cervia, Cesena and Cesenatico is free of charge by showing your WSG-accreditation badge.

- Airport: Bologna International Airport (BLQ), Airport shuttle is offered and will cost 50 Euro.
- Train station: Bologna Centrale, Railway station

# 12. ACCREDITATION

The Accreditation-Badge (Personal WSG2023 Pass) of all participants will be handed over upon arrival.

# 13. FAIR PLAY POLICY & WADA RULES/TESTING

The Organizing Committee implements the Fair Play Philosophy into the WSG 2023.

All Championships and competitions will be organized under WADA Code Regulations.

Each participant must sign the CSIT Anti Doping Policy: see attached to this Bulletin 1.

### 14. VISA INFORMATION

EU nationals do not require a visa to enter the Republic of Italy.

Generally speaking, all other foreigners require a visa for stays in Italy. A visa is not required for semiannual visits of up to three months for nationals of those countries for which the European Community has abolished the visa requirement.

Nationals being in need for Visa to enter Italy are required to contact the respective Italian embassy or consular section being responsible for your country.

A list of those countries can be found on the website of the Italian Foreign Office under:

Visas are issued by the mission responsible for the area in which the applicant has his/her ordinary residence or domicile.

Participants being in need for Visa are requested to register online as mentioned above prior to the deadlines given.

The Organizing Committee will <u>upon request</u> send invitation letters to the respective delegation.

The information the Organizing Committee need to fill in the Invitation Letter are the following:

- Data of participants: First Name; Family Name; Number of Passport; Role in the delegation (manager, coach, official, athlete, companion, other);
- The competitions, sport or other activities your delegation will participate.

The Organizers would like to underline that Visa procedures are the responsibility of the applying person/s. In any case but in particular in the case of late registration or failing respective procedures the Organizers are not responsible for the participant's visas. The Organizers however will be glad to assist when questions on Visa procedures should apply.

The Organizers would also like to stress strongly that no visas will be issued at the Swiss passport control and all documentation has to be prepared beforehand.

## 16. CULTURAL PROGRAMME

Details will be published on the official WSG 2023 Webpage and later in the WSG 2023 App.

### 17. CANCELLATION POLICY

In order to be officially registered all registration payments have to be transferred to the organizer until the definitive registration deadline on June 30th, 2023.

- In case of cancellation by a registered participant until June 30th, 2023, the organizer will refund all payments (100%).
- Cancellation between July 1st and July 15th, 2023, the organizer will refund 50% of the total sum.
- Last minute cancellation between July 16th and July 24th, 2023, the organizer will refund 25% of the total sum.
- After July 24th 2023 no refund will be conducted.

Take note that: a special total Insurance policy Covid-19 related could be purchased for WSG2023 upon request. Information see below.

# 18. HEALTH AND INSURANCE POLICIES

EMILIOC created 3 special tailor-made insurance policies for WSG2023, whereas 2 of them are Covid-19 related.

- A total cancellation policy covid-19 related: each participant will be able to cancel the participation at the Games, by showing EMILIOC the positive result of the Covid-19 test. The participant will we be fully reimbursed of all WSG package expenses. The insurance policy is optional. The insurance is added on the registration platform and can be chosen with an additional cost of the total amount of the WSG package fee. The registration process on the official website provides the declaration. Further information will be delivered on the WSG2023 official website!
- Acc. to the Sports Regulations of CSIT, basically participating Unions have to make sure that their participants have got individual health and accident insurance as well as repatriation assistance contracts. Acc. to the Italian legal framework a WSG2023- Health Insurance is provided to cover athletes and sports delegation's members for all health risks related to the sport practice and participation at the official events from the arrival to the departure and linked to the official WSG 2023 sports facilities and facilities of the Opening and Closing Ceremonies. The insurance policy is free for participants.
- An insurance policy tailor made for positive result of the Covid-19 test during the WSG2023: in case of positive result of the test Covid-19 during the participation at the event the participant is obliged to undertake all the health measures among which the quarantine/ isolation measures and to delay the departure to go back home. An insurance policy can provide the participant a reimbursement to contribute to the supplementary expenses (accommodation, food etc.). The insurance policy is optional and added on the registration platform. It can be chosen with an additional cost to the total amount of the WSG package fee.
