3.	IFA Headquarter in Linz – decision			
	i. Finances			
	IFA was provided the possibility to get a subsidy of 50 T € from the State Austria/Ministry of Foreign Affairs and Defence to support the hosting of the IFA office in Austria. This means 50 % up to a maximum of 50 T € of the total costs of more than 100 T € for the IFA office are supportable.			
	ii. Tasks			
	A working group composed by Karl, Winnie, Alwin, Roger and Jörn devel- oped in a meeting dated Saturday 11. November 9 am – 3 pm a proposa for the tasks run by the IFA Headquarter in Linz.			
	Under the responsibility of the Secretary General the Headquarter will be focus on event management including event marketing and all event re- lated communication with the member federations.

	The working group presents the proposal to hire Mr. Christoph Oberlehne as fulltime IFA Administrative Director. The contract should be time limite according to the subsidy from the State of Austria starting 1 January 201 to 31 December 2019.

	On the basis of this year's events the future of the events was discussed in different aspects.			
	The IFA Board of Directors is convinced that quality of the events need improvement star ing with starting in 2018 and with qualifiers staring in 2017. The 2017 edition should be			

	played according to the existing system as one team per continental federation (Africa, Asia, Oceania, Europe, North and South America) is eligible.
	The following points have been agreed within the discussion:
	8 teams shall participate in the event.
	Continental cup holders shall continue to be directly qualified for the World Cups.
	A World Cup Series should be establish to offer the opportunity to qualify for world cup in a different way.
	Women's and men's competitions should be carried out at the same time/venue on the basis of the same conditions.
	The economic conditions for host/participants must be adopted.
	Proposal:
	The Chair of the Sports Commission is asked to develop a written concept until 30 th No- vember 2016 to be sent out to all member federations and the IFA Athletes ´ Commission for feedback until end of January 2017.
	Voting: The proposal is accepted unanimously.
5.	Financial Report 2015 – report and approval

	Proposal: The Board of Directors approves the Financial Report 2015.
	Voting: The proposal is accepted unanimously.
6.	Situation Fistball in India – report and decision
	IFA has carefully studied the outcome of the FFI Congress dated Sunday 4th September 2016 in Dehli.
	IFA has learned that Mr. Karam Singh has been "elected" as President, Mr. Parag Wankhade as Working President and Mr. Sandeep Bhosale as Secretary General. A real voting has not taken place due to fact that no candidates have been submitted by the re- gional associations as foreseen in the election guidelines sent out prior to the Congress.
	The duties of the named representatives are not clear, as FFI did not send any standing orders or statues as promised.
	With reference to the IFA Anti-Harassment Policy and Procedures as approved by the IFA Board of Directors Mr. Karam Singh, promised in meetings with the IFA President and the IFA Secretary General not to integrate Mr. Parag Wankhade for these elections in the gov- erning bodies of FFI.
	IFA has also has learned and recognized that FFI was not participating in the IFA 2016 Fistball Women´s World Championship in Brazil which was also agreed between IFA and FFI in Nuremberg.
	This means FFI did not fulfil two of the main duties agreed between FFI and IFA in Nurem- berg.
	FFI did also no show interest to participate in the 2nd Fistball Asia Cup for which the invita- tion was sent out by Mr. Usman Ahmed (PAK) to take place from 14th to 18th November 2016 in the Imperial College of Business Studies, Lahore, Pakistan.
	The second federation named "The Fistball Federation of India" was founded and regis- tered under the leadership of Secretary General T. Bala Vinayakam in June 2016. The membership is composed by some former FFI members. The IFA membership of this federation was provisionally accepted by the Executive Board to allow this federation to participate with an U18 men's team at the IFA 2016 Fistball U18 Men's World

Championship Germany in Nuremberg expecting that the FFI like all the recent years will not show interest or like the last year cancel its participation in the last minute.

As you know things went different this year and two male teams from India participated in Nurmberg.

Dated 9 November 2016 the new federation confirmed in written that they have planned to develop fistball in India by implementing fistball in schools and colleges as well as conducting state and national level championships "but we are waiting for IFA board members to decide which federation to continue in India which will be helping to develop this game without any problems."

Furthermore, they expressed their interest to host the Asian Fistball Championship 2017 in India (Chennai).

According § 18 "Termination of membership" of the IFA Statues the membership terminates upon:

e) Loss of status as a national federation.

Different from a) to c) in which cases the expulsions decision has to be taken at the Congress with a two-third majority it is not foreseen that this determination has to be made by IFA Congress. As it is not fixed otherwise in the IFA Status, which body should take that determination the IFA Board of Directors as the highest ranked body has the capacity to take this determination.

Proposal:

The IFA Board of Directors remembers all member federations to act according to the principles of good governance as laid down in the IFA Code of Ethics.

The IFA Board of Directors is afraid that FFI lost the status as national federation in India.

The IFA Board of Directors mandates the IFA Secretary General to hear the FFI according to point 31 IFA Juridical Regulations regarding the above mentioned concern.

In the case that FFI does not answer within 14 days the IFA Board of Directors determines the loss of status of FFI as a national federation in India coming into force 31 December 2016.

In the case that FFI answers within 14 days a final decision will be taken by the Board of directors in decision making process outside a meeting.

In the case that the FFI membership terminates 31 December 2016 the IFA Board of Directors confirms according § 15 Admission of member federations the provisional membership of "The Fistball Federation of India" coming into force 1 January 2017. The membership has to be confirmed by the next Congress and the provisional membership of the federation will be reviewed by the Board of Directors at the end of 2017.

Voting: The proposal is accepted unanimously.

7. The World Games 2017 – report and decision concerning cooperation with the Schools Sport Association Wrocławski Szkolny Związek Sportowy

According to an information dated 24 October 2016 the Worclaw Organiozing Committee needs to point out a particular partner to each discipline. As there is no fistball federation in Poland so fare (see also appendix 10) the Organizing Committee suggested to take the local Schools Sport Association (Szkolny Związek Sportowy – in polish) to promote the disciplines and the whole evet itself.

You can find a draft for this letter as Appendix 03.

Proposal:

The Board agrees with the proposal.

Voting: The proposal is accepted unanimously.

8.	Fee concerning internationa	al matches – report and decision	

EFA has developed a paper "Länderspiele" (see appendix 04) and requests to change the IFA Competition Rules (IFCR) as valid as for 11 November 2011 (see appendix 05) by deleting point 2.2 International Matches which is as following

2.2.1 International matches are competitions between teams of all age levels, for men and women, pertaining to member federations of IFA, who are free to agree them.

2.2.2 Once a match has been agreed, the organizing member federation shall notify the IFA general secretariat of its time and venue.

2.2.3 After the match the organizing member federation shall

2.2.3.1 forward the original competition reports to the responsible member of the Committee and communicate the names of the referees without delay,

2.2.3.2 pay a fee according to Art. 8, par. 1.2 below to IFA within four weeks of the match taking place.

8.1.2 The hosting member federation of friendly international matches shall compensate IFA with a fee of 50 Euros.

EFA requests to make the Regional Associations responsible for friendly matches.

The Board discussed controversially.

Proposal:

The Board in general agrees to review the IFA Competition Rules (IFCR) and asks the Secretary General and the IFA Sports Commission to make a proposal for the next meeting of the Board.

Friendly matches should be under the authority of the Regional Associations including the respective fee of 50 Euro per match. The Regional Associations should think about which service for the host is covered by the fee and make this clear in advance.

The Board asks EFA to review the paper "Länderspiele" in general as some of the points may be mistakable.

Voting: The proposal is accepted unanimously.

9. Ball rights 2017 - report and decision

IFA has approved two new balls (see appendix 06) and signed a contract with Drohnn as new ball partner starting 1 November 2016 (see appendix 07).

This includes a bidding process for the IFA events 2017 and beyond.

All events of Regional Associations are not part of this bidding process and have to be agreed directly by the Regional Associations.

Proposal:

The Secretary General will develop a bidding process to generate more revenues and make the decision making process transparent.

IFA will provide all three official ball partners to make a proposal concerning the different IFA 2017 events.

The bidding process for The World Games 2017 should start as soon as possible and end before mid of December.

Voting: The proposal is accepted unanimously.
