1. Registration of players/coaches/officials and pictures

The registration process will be open from

12 March 2018 – 31 May 2018.

A player/coach/official/extra official can only be registered if all information is available. We kindly ask you to register each player/official/staff member for your entire delegation in the fistball database by **31 May 2018**:

All information in this form is definitely necessary for the TV production, professional media work, accreditation and for the media work of the organizers.

For the registration process, the following mandatory data are required:

- Gender
- Representing Country
- Passport Family Name
- Passport Given Name
- Preferred Family Name
- Preferred Given Name
- Date of Birth
- Place of Birth
- Club Name
- Photo
- Height
- Player's email
- Jersey Number
- Number of Matches in national team
- Position (spiker, setter, defense player)
- Specials (Vegetarian/Allergies etc.)

Please use the mail address of the player. The players will then get a mail with their own login data. The players can then update further personal information on their own. That will help to get more information about all players for TV stations, media, moderation etc.

Please note that the players are not able to see information of other players or to add oneself to a longlist or a final team nomination. Only the head of delegation can create these lists/teams.

It is of special importance to us to assure that we see a major obligation to handle the data submitted to us with care and to protect these from misuse. For future events it's not necessary to register a player again, it's possible to add that registered player to a long list or final team nomination just by one click.

Information about portrait pictures:

- upright format
- neutral, single-colour (grey or white) background
- Motive: Head and chest
- High resolution
- Official clothes (shirt, sweater etc.)
- Please do not send photos taken with mobile phones.

The pictures will be used for the accreditation card and the internet presentation.

2. Final team nomination

The national federation have to provide a long list with all possible players until **31 May 2018** by register all players in the database mentioned in Bulletpoint 1. **No player can be added after 31 May 2018.** The final team nomination has to be made out of the long list between **15 May and 30 June 2018** by selecting the players in the database on www.fistball.org.

The substitution of an ill/injured player is possible until the beginning of the tournament, but the players must have been announced at the long list provided by 31 May 2018.

3. Team Photos & Player's presentation video

The National Federation is to send a team picture (including names of all players on the photo in the mail) as .jpg or .gif to media@fistballwwc.com until **31 May 2018** at the latest.

We'd like to create a video for the presentation of each player for TV coverage and the videowall in the stadium. Please send us a short video of each player/official like the following example until **31 May 2018** (stand slight diagonal and cross your arms):

- Landscape format
- neutral, single-colour background (bright illuminated!) (e.g. red jersey in front of a white background)
- Motive: upper body
- Resolution: as high as possible, best HD (1080x1920px)
- Official clothes (jersey, shirt, sweater etc.)

5. Balls

On the basis of the court and weather conditions, IFA and referees are going to decide which of the following types of balls is used during a match:

- Sportastic Women Premium dry 330 (dry conditions)
- Sportastic Women Micro dry 320 (dry conditions)
- Sportastic Women Micro wet 320 (wet conditions)



6. Ticketing

The ticketing sale started in the middle of December. Early bird tickets with a special discount are on sale until 18 March 12pm CET. Later the normal pre sales period starts with prices which are approx. 20% higher than during early bird phase. We kindly ask you to inform your fistball fans who plan to go to the World Championship as spectators to buy as soon as possible to get the best price possible.

7. Anti Doping

Regarding to the "IFA Anti-Doping Rules based on Wada's Models of Best Practice for International Federations and the World Anti-Doping Code (valid from 1.1.2015)" the International Fistball Association requires ALL athletes competing in the IFA 2018 Fistball Women's World Championship to fill out and hand over to the Secretary General before the beginning of the competition the Anti-Doping Consent Form as original. The Anti-Doping Consent Form is added as appendix to this Bulletin.

In preparation for IFA 2018 Fistball Women's World Championship we kindly ask you to ensure that ALL team members review this information carefully. If you have any questions, please contact IFA Anti-Doping Administrator Joern Verleger (j.verleger@ifa-fistball.org ; +49 176 16 41 89 33).

IFA has signed the WADA World Ant-Doping Code (Code). The WADA and IFA Anti-Doping regulations are in force for all member federations.

Doping test can be done at any time between arrival and departure. Athletes have the obligation to follow the testing order. If they wish they can be accompanied by a person of trust.

WADA Prohibited List valid 1.1.2018 is in force.

This is an educational exercise and test to enhance the knowledge of Anti-Doping matters for elite athletes and their support personnel concerning subjects such as doping control procedures, the WADA Prohibited List, athletes' whereabouts reporting and Therapeutic Use Exemptions (TUE).

IFA ANTI-DOPING CONSENT FORM

As a participant in the IFA 2018 Fistball Women's World Championship in Linz (AUT), I hereby declare as follows:

I acknowledge that I am bound by, and confirm that I shall comply with, all of the provisions of IFA Anti-Doping Rules (as amended from time to time) and the *International Standards* issued by the World Anti-Doping Agency and published on its website.

I acknowledge the authority of IFA under the IFA Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with, the IFA Anti-Doping Rules.

I also acknowledge and agree that any dispute arising out of a decision made pursuant to the IFA Anti-Doping Rules, after exhaustion of the process expressly provided for in the IFA Anti-Doping Rules, may be appealed exclusively as provided in Article 13 of the IFA Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).

I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
