- 1. Opening and approval of the agenda / Eröffnung und Beschlussfassung zur Tagesordnung The President opens the meeting. The proposed agenda is approved.
- 2. Minutes of the last board meeting approval / Protokoll der letzten Sitzung Genehmigung The last board meeting was dated 5 January 2019. The minutes were sent out with the invitation to this meeting on 22nd January 2019 (appendix 01).

According to the IFA Standing Orders the minutes were accepted and published on the IFA website as no member of the Board disagreed within 14 days after receiving the minutes.

3. Approval of the German version of the IFA Standing Orders / Verabschiedung der deutschen Version der Geschäftsordnung

The draft is only a translation from the English version, which was approved by the board in its meeting on 4 November 2018. The Secretary General received proposals/recommendations for changes to the sent-out draft from Franco Giori. The Board discussed the proposal and agreed unanimously to accept the proposal as a German translation and to forward the proposals/recommendations to the Board, which will be elected in Winterthur to take into consideration for the Standing Orders 2019.

Proposal:

The Board approves the enclosed German version of the Standing Orders (see appendix 02d). The Secretary General is asked to update the §§ of the English and the German version according the current Status without any further approval by the Board.

Voting: The proposal is accepted unanimously.

4. Financial Report 2018 - current status / Jahresabschlusses 2018 - Sachstand

The IFA Treasurer informed the Board orally about the provisional financial report 2018 with a plus of around 24.000,- €. The final report will be approved by the in its next meeting.

5. External Auditing Financial Report 2017 and 2018 – approval / Externe Wirtschaftsprüfung Jahresabschluss 2017 und 2018 – Beschlussfassung

The IOC calls for external auditors within the IOC Recognition Process.

The external auditor reports to shareholders or members who are outside the organisations' governance structure. The objectives are to add credibility and reliability to financial reports from the organisation to its stakeholders by giving opinion on the Financial Report. It coverages the Financial Report and financial reporting risks.

The report will be forwarded to the internal auditors before their auditing.

Proposal:

IFA contracts Markus Iten, Oberdorfstrasse 8, CH-6314 Unterägeri / Schweiz with the external auditing of the IFA Financial Reports 2017 and 2018.

Voting: The proposal is accepted unanimously.

6. Amendments to the IFA Statues – proposal to the IFA 2019 Congress / Ergänzung der IFA Satzung – Vorschlag an den IFA Kongress 2019

Even if legally confirmed by the Austrian authorities the Secretary General withdraws the proposal to change the statues concerning the internal/external auditors which was foreseen in IV. Commissions of the draft following several emails and communications this week.

Proposal:

The Board accepted unanimously the proposal with the before mentioned change and forwards the draft for amendments (see appendix 03) to the IFA 2019 Congress.

Voting: The changed proposal is accepted unanimously.

7. Fistball – Rules of the Game valid as for 1 April 2019 – approval / Faustball - Spielregeln gültig ab 1. April 2019 – Genehmigung

The IFA Sports Commission proposes changes of the Fistball – Rules of the Games (see appendix 04).

Proposal:

The Board approves the draft for Fistball - Rules of the Game (see appendices 04/04d) valid as for 1 April 2019.

Voting: The changed proposal is accepted unanimously.

8. IFA Juridical Regulations 2019 - approval / IFA Rechtsordnung 2019 - Genehmigung

The IFA Sports Commission proposes the changes of the IFA Juridical Regulations.

Rules regarding yellow and red cards at IFA competitions (Valid for all members of delegation according to match report form):

If a player/delegation member receives two yellow cards in two different games for his team within a tournament, he is automatically suspended for the next game.

Single yellow cards are to be cancelled before the semi-finals.

This is to avoid the scenario where a player/delegation member is suspended for a second yellow card he received in the semi-finals, for the final.

If a player/delegation member receives a red card, that player/delegation member will be automatically suspended for the next game.

In addition, further sanctions by the IFA Jury may be imposed in case of a red card.

Deutsche Version:

Regelungen bzgl Rote und Gelbe Karten bei IFA Wettkämpfen (Gültig für alle Delegationsmitglieder gemäß Spielbericht)

Wenn ein Spieler/Betreuer 2 Gelbe Karten in zwei verschiedenen Spielen eines Turniers erhält, so ist dieser Spieler/Betreuer automatisch gesperrt für das folgende Spiel.

Einzelne Gelbe Karten werden vor dem Semifinale gestrichen, um zu verhindern, dass ein Spieler/Betreuer für das Spiel um die Medaillen aufgrund einer Gelben Karte gesperrt ist.

Wenn ein Spieler/Betreuer eine Rote Karte erhält, so ist dieser Spieler/Betreuer automatisch für das folgende Spiel gesperrt.

Zusätzlich kann die IFA-Jury im Falle einer Roten Karte weitere Sanktionen/Strafen aussprechen.

Proposal:

The Board approves the draft of the IFA Juridical Regulations 2019 (see appendices 05).

Voting: The changed proposal is accepted unanimously.

- 9. Preparation of the 2019 events / Vorbereitung der Veranstaltungen 2019
 - a) IFA 2019 Fistball Men's World Championship 11 17 August / Winterthur (SUI)

The LOC contracted the IFA Media team and the court branding from IFA.

Every Thursday at 8:30 a.m. there is a Skype call with LOC President Toni Maurer, Jörn and Christoph.

The next visit in Winterthur is dated on 2 March 2019 but will maybe changed to 30 March 2019.

Winnie Kronsteiner as Technical Delegate of the event explains the idea of the schedule which will be sent out to all Board members for a last internal check in detail. The members of the Board are asked to keep the draft confidential and to provide feedback if necessary Wednesday 6 February 2019 at the latest. The members welcomed in general the concept behind the schedule with 12 teams playing the double elimination and 6 teams playing the President´s Cup after the preliminary round. All teams will have 8 to 9 matches.

With this proposal 7 out of 19 (37 %) of the Board would be female (currently 31%). With this proposal 3 out of 10 (30 %) of the Executive Board would be female (currently 0%). Voting: The proposal is accepted unanimously.

d) CSIT IFA 2019 Fistball Amateurs World Cup 2 – 7 July / Tortosa (ESP) The registration deadline for teams is 22February 2019.

With the new record of 29 World Tour hosts on 5 continents, the new season of the still young IFA Fistball World Tour starts at the end of February 2019. 10 tournaments take place in South America, 16 in Europe and one tournament each in India, the USA and Australia. Two out of the highest ranking category, the so-called major tournaments, are each organized in Brazil and Switzerland and one in Germany. (see appendix 07).

Currently around 80 club teams have registered. The registration deadline for club teams to participate in the World Tour runs until 4 February.
