Rules:

1. Pick your favourite slot.
2. First come - first served! Be fair: do not change someone else's entries!
3. Picking of just one training session possible from 10:00 to 16:00.
4. No training on centre court possible.
5. Schedule closed at 5 September.

We tried to offer the best training and warm up conditions that are possible at the allocated venue by the organizing committee. That includes two full size warm up and training courts.

3. Jerseys

Every team must bring 2 sets of jerseys in different and contrasting colours. Coaches and substitute players wear shirts of a different colour than the team's colour. The jersey colours have to be added to the file **latest by 8 September** [info sheet competition management wtf salzburg.xlsx](#)

The IFA Technical Delegate decides about the colours of the jerseys for the following day. The coaches wear different colours than the players on the court. Regarding advertising the IFA Competition Rules (IFCR) valid from 4 November 2018 (clause 8) are applied.

Due to different circumstances in Salzburg we had to change the plans for the official welcome reception for all delegations.

5. IFA Athletes´ Forum

Within the Joint meeting of IFA/EFA/PAFA with the IFA Athletes´ Commission in Winterthur it was suggested by the athletes to establish an IFA Athletes´ Forum open for all interested players at every mayor IFA event.

The inaugural IFA Athletes´ Forum will take place at the welcome day of the IFA 2019 Fistball World Tour Finals on 12 September 2019, 20:30 **at Sportzentrum Nord**.

Topics are future development of IFA events “What should IFA focus on?”. After a short introduction of IFA President Jörn Verleger all team members are warmly invited to share and discuss their vision of IFA events participate.

The working language will be English.

6. Substitution of an ill/injured player

The substitution of an ill/injured player is possible until the beginning of the tournament, but the players must have been announced at the long list provided by 15 July 2019.

7. Payment Team Catering and Hotel

Payments of your hotel and the meals you ordered for team catering has to be paid in cash to IFA honorary president Karl Weiß at the technical meeting on 12 September.

All teams received a mail with information of the costs of the hotel. You´ll receive an invoice and all meal vouchers for every day as ordered.

Saturday: Multi sports tournament “Ballo Ballone”. Who’s gonna be the best in ball sports? Also spectators are allowed to participate in Volleyball, Table Tennis, Football and Fistball.

10. Anti Doping

Regarding to the “IFA Anti-Doping Rules based on Wada’s Models of Best Practice for International Federations and the World Anti-Doping Code (valid from 1.1.2015)” the International Fistball Association requires ALL athletes competing in the IFA 2019 Fistball World Tour Finals to fill out and hand over the Anti-Doping Consent Form as original to the IFA Secretary General before the beginning of the competition. The Anti-Doping Consent Form is added as appendix to this Bulletin.

In preparation for IFA 2019 Fistball World Tour Finals we kindly ask you to ensure that ALL team members review this information carefully. If you have any questions, please contact IFA Anti-Doping Administrator Christoph Oberlehner (c.oberlehner@ifa-fistball.com).

IFA has signed the WADA World Ant-Doping Code (Code). The WADA and IFA Anti-Doping regulations are in force for all member federations. The WADA Prohibited List valid 1.1.2019 is in force. Doping test can be done at any time between arrival and departure. Athletes have the obligation to follow the testing order. If they wish they can be accompanied by a person of trust.

IFA ANTI-DOPING CONSENT FORM

Inoffizielle Übersetzung (bindend ist ausschließlich die englische Version):

As a participant in the IFA 2019 Fistball World Tour Finals, I hereby declare as follows:

I acknowledge that I am bound by, and confirm that I shall comply with, all of the provisions of IFA Anti-Doping Rules (as amended from time to time) and the *International Standards* issued by the World Anti-Doping Agency and published on its website.

I acknowledge the authority of IFA under the IFA Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with, the IFA Anti-Doping Rules.

I also acknowledge and agree that any dispute arising out of a decision made pursuant to the IFA Anti-Doping Rules, after exhaustion of the process expressly provided for in the IFA Anti-Doping Rules, may be appealed exclusively as provided in Article 13 of the IFA Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).

I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
